



BEFORE ME, the undersigned authority, on this day did personally appear **Inv. R S Hagler #527**, a peace officer in and for the City of Bedford, Tarrant County, Texas, and after being duly sworn on oath, deposes and says that he has good reason to believe and does believe that **Jones, Mark Anthony** committed the offense of **Unlawful Carrying of Handgun by License Holder-Intoxicated**, to-wit: **Defendant Mark Anthony Jones intentionally or knowingly or recklessly carried a handgun while intoxicated and operating a motor vehicle, under the authority of Subchapter H, Chapter 411 Government Code, While Intoxicated.** This information is based upon the following facts and information, to-wit:

I.

On March 23, 1999 at 4:54 p.m. Officer Michelle Rodela # 605 was on patrol in the 2200 block of Airport Freeway east service road Bedford Tarrant County, Texas 76022 when she observed the defendant. Rodela reports that she witnessed the defendant operate a black Suburban with Texas license number [redacted] in the parking lot of Chiles. She wrote that she witnessed this driver strike a parked unattended vehicle described as a Brown 1983 Buick Park Avenue 2 door with Texas license number [redacted]. The defendant failed to stop once he struck the other car, and drove out of the parking lot heading east on the service road of Airport Freeway in the 2400 block.

Officer Rodela using her emergency lights and siren on her marked police unit number 22 effected a traffic stop of the Jones subject which he stopped in the 1800 block of Park Place. Officer Rodela contacted the driver at the driver's door where she then detected a strong odor of an alcoholic beverage omitting from the driver's window. The driver was slow in his response of getting his driver license when asked by Officer Rodela to see it. The defendant was identified by Texas driver license number [redacted] as Jones, Mark Anthony, WM, 12/03/1956. The driver exited the vehicle and staggered out of it. The driver's speech was slurred. Officer Rodela wrote that she had checked the defendant on the unit's computer and found that Jones is a Concealed Handgun License holder. Rodela asked Jones where his weapon was, and his response was, he didn't know. Officers later found the Glock pistol in the vehicle concealed between the driver's seat and the passenger seat. Officer Rodela secured the weapon in the police unit for evidence, and safekeeping.
