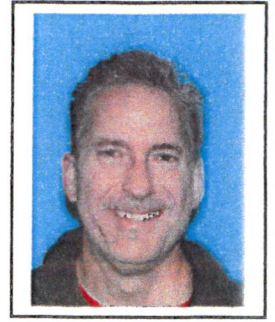

ARREST WARRANT AFFIDAVIT

THE STATE OF TEXAS §

COUNTY OF TARRANT §

BEFORE me, the undersigned authority, on this day personally appeared the undersigned Affiant, who after being by me duly sworn on oath deposes and says: My name is Pedro SOLTERO, Detective, Grapevine Police Department, and I have good reason to believe that between 01/01/2005-05/31/2005, Faith Christian School, at 730 East Worth Street, 76051, City of Grapevine, Tarrant County, Texas, **Jeffrey Ward Brooks**, a white male born on 09/17/1964, did then and there commit the offense of **Indecency with a Child-Sexual Contact**, a 2nd Degree Felony, in violation of Section 21.11(a)(1), Texas Penal Code.

My belief is based upon Grapevine Police Department offense report #1900064458 and the subsequent follow-up investigation conducted by your Affiant, and other law enforcement officers.

On 11/30/2019, Ofc. T. Smith was dispatched to 1007 Ira E. Woods Avenue, Grapevine, Texas 76051 (Grapevine Police Department) in reference to a sexual assault report. Ofc. Smith met with [REDACTED] and her parents, Joe and Kimberly Croce. [REDACTED] stated her former teacher, Jeffery "Jeff" Brooks, sexually assaulted her. This occurred in 2nd Grade when she was 7-years-old (2005). [REDACTED] is currently 23-years-old. The sexual assault occurred at 730 East Worth Street Grapevine, Texas, 76051 (Faith Christian School).

[REDACTED] recalled she had a private piano lesson with Jeff when he asked her if she knew what a penis and a vagina were. Jeff pointed to his penis and then touched her vagina (over clothes) and indicated that was her vagina. [REDACTED] told Joe and Kimberly the following day. Next, Ofc. Smith spoke with Kimberly. Kimberly recalled she dropped [REDACTED] off at school and [REDACTED] walked the opposite direction of Jeff. Kimberly asked [REDACTED] why she had done that, and [REDACTED] said, "She had bad thoughts when it comes to Jeff" and pointed to her vagina.

It should be noted; [REDACTED] decided to pursue the matter after going through therapy and after she found out Jeff was currently employed as a teacher in another school.

On 01/13/2020, Detective B. Gullion interviewed [REDACTED]. [REDACTED] recalled, during her private piano lesson, inside Jeff's classroom, she and Jeff were sitting on the floor, and they talked about music. Normally, they sat on the bench and talked about music, but on that day, they sat on the floor. As they talked, Jeff changed the subject and asked [REDACTED] if she knew what a penis was. [REDACTED] remembered Jeff's countenance changed and he was "more jolly" about the new subject. [REDACTED] was not sure what her response was, but speculated she just sat there and did not answer. Jeff pointed to his penis and indicated he had a penis.

Next, Jeff asked [REDACTED] if she knew what a vagina was. Again, [REDACTED] could not recall what she said or did, but advised she probably just sat there and did not answer. Jeff pointed towards her vagina and indicated she had a vagina. Jeff continued and reached between [REDACTED] legs and touched her vagina (over clothes). Jeff moved his fingers as if he were "tickling" her vagina. Additionally, Jeff asked her if she knew where the penis went. Jeff told [REDACTED] it went in the vagina and they went together. [REDACTED] remembered being "really freaked out" by the conversation and described Jeff as being "cutesy" with her during his conversation with her. [REDACTED] walked out of his classroom and she recalled she felt "dirty."

Initially, [REDACTED] thought she was 7-years of age when the aforementioned occurred but after some thought, she believed it occurred in the spring of 2005. At the time, she was 8-years of age.

Jeffrey Ward Brooks is a white male born on 09/17/1964. Jeffery is 6'03, weighs approximately 200 pounds and can be identified by Texas driver's license [REDACTED]

WHEREFORE, I request that an arrest warrant issue for the suspect hereinbefore designated according to the laws of this State.
